







# OPPORTUNITY-LA ACCOUNT CLOSURE FORM

# ADDITIONAL INFORMATION

Complete and return the Account Closure Form only if you <u>no longer want</u> your child to participate in the OPPORTUNITY LA college savings account program. Please be aware that once the account is closed, it may not be reopened. All Program contribution funds will be returned to the Program. If the student has any non-program fund contributions, Opportunity LA will issue a check to the student in the amount of the non-program funds-upon closure of the account.

# What is Opportunity LA?

The City & County of Los Angeles Opportunity LA program, in partnership with Los Angeles Unified School District, will automatically open a college savings account with a \$50 deposit for each student entering first-grade or a program grade in LAUSD.

#### What are the benefits for my Child?

The Opportunity LA children's savings account program provides benefits such as an initial \$50 deposit into a college savings account held in your child's name. There will be opportunities to earn additional money through incentives that you and your child can participate in. The children's savings account can be used as a financial investment tool allowing for financial rewards from friends, family, and community resource organizations to deposit funds into the account.

#### What information is required?

Opportunity LA accounts are opened in partnership with LAUSD. LAUSD will confidentially provide your child's name, school, address, telephone number, and birth date, with the Los Angeles Community Investment for Families Department. Your child's information will only be used for the purpose of opening and maintaining an Opportunity LA account with Citibank, and for no other purpose.

# What if I do not want my child to participate?

If you no longer want your child to participate in the Opportunity LA children's savings account program, please complete the **Account Closure Form**.
